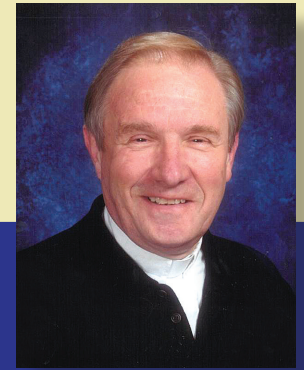


Vision

About the Fund

The Father Thomas C. Champoux Fund is an endowment fund designated by the Catholic Charities, Serving Central Washington, Board of Trustees.

The Fund was created to honor the service of Father Thomas C. Champoux to Catholic Charities, first as the director and then as the chairperson of the Board.

Any contributions made to the Fund, once accepted, represent an irrevocable charitable contribution to Catholic Charities.



Purpose

The purpose of the Father Thomas C. Champoux Fund is to enhance the agency's mission:

“Motivated by Christ’s love, we bring hope to life, especially for those most in need.”

The Fund will benefit programs for children and families throughout the Diocese of Yakima which, ultimately, will reduce the impact of poverty on individual lives, specifically by helping to:

- Nurture children
- Strengthen families
- Empower people to enhance the quality of their own lives and move towards self-sufficiency

Use

As an endowment, the corpus of the Fund will be left intact for perpetuity. Only income from the investment of the fund will be distributed, once the Fund reaches a target amount of \$250,000. **We have \$24,000 to go!**

The proceeds from the investment of this Fund will be distributed annually.



The Fund is a perpetual endowment designed to meet the future and current operational needs of the programs of Catholic Charities and to increase services we provide.

The Fund provides a way for you to leave an ongoing legacy.
